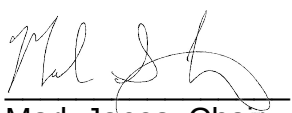

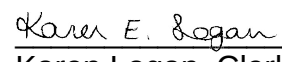
Chair Mark Jones asked to forgo comments due to event they need to attend.
