Subject: Davie County/Yadkinville Water Interconnection

Dear Mr. Koser,

Davie County is pleased to provide this letter of support for a grant application for a water line interconnection between the Yadkinville/Yadkin County water system and the Davie County Water System. Water Treatment is extremely important to our community and economy. It supports the bulk of our industrial base and future industrial sites. As proposed, this interconnection would principally function to provide an emergency source of water to either system in the case of a major system failure. This project has been of interest and a point of discussion for several years to reinforce the Yadkinville, Yadkin County and Davie County water systems (1) against severe drought, (2) as a back-up in the case of a major water system production or distribution failure, and (3) as an expansion of regional water system cooperative operations.

Davie County has a Water Treatment Plant (WTP) in Cooleemee on the South Yadkin River and another WTP at Sparks Road on the Yadkin River. With Davie County already having interconnections with the Winston-Salem water system on the northeast, Town of Mocksville water system in the central part of the county, an interconnection with the Yadkinville/Yadkin County water system would provide a vital emergency source for both the Yadkinville/Yadkin County water system and Davie County. Regionalization and system collaboration will continue to effectively address our local, state and national water challenges.

Please keep us informed as this project progresses, and be assured we will cooperate in any way possible to bring this project to completion.
