6. Adjourn - Chair Weatherman

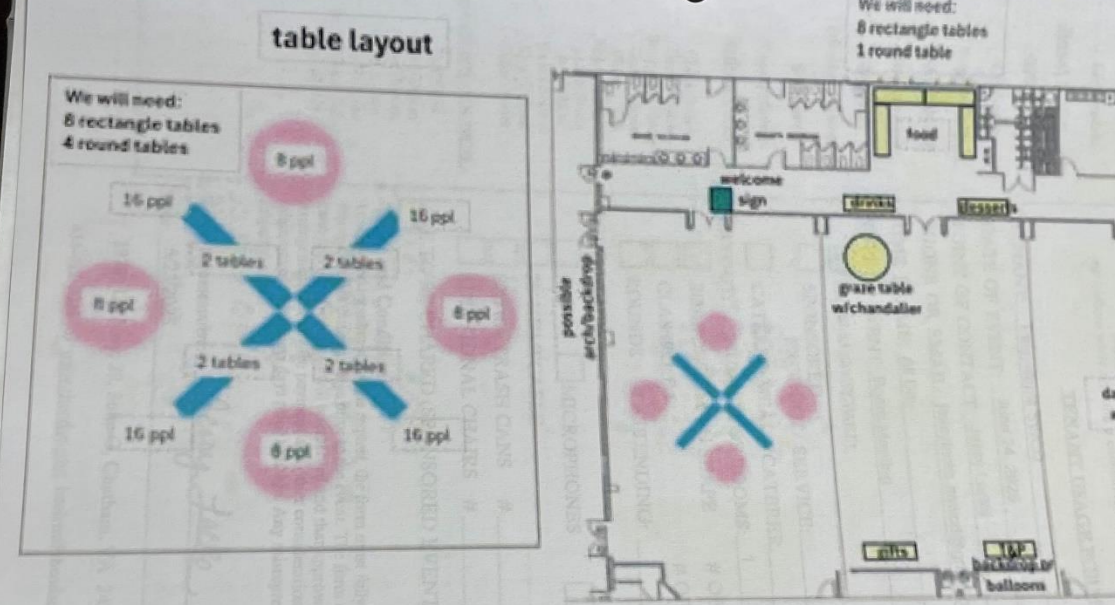
Paul Moore made the motion to adjourn. Jesse Ledbetter seconded the motion. All were in favor, and the motion passed.

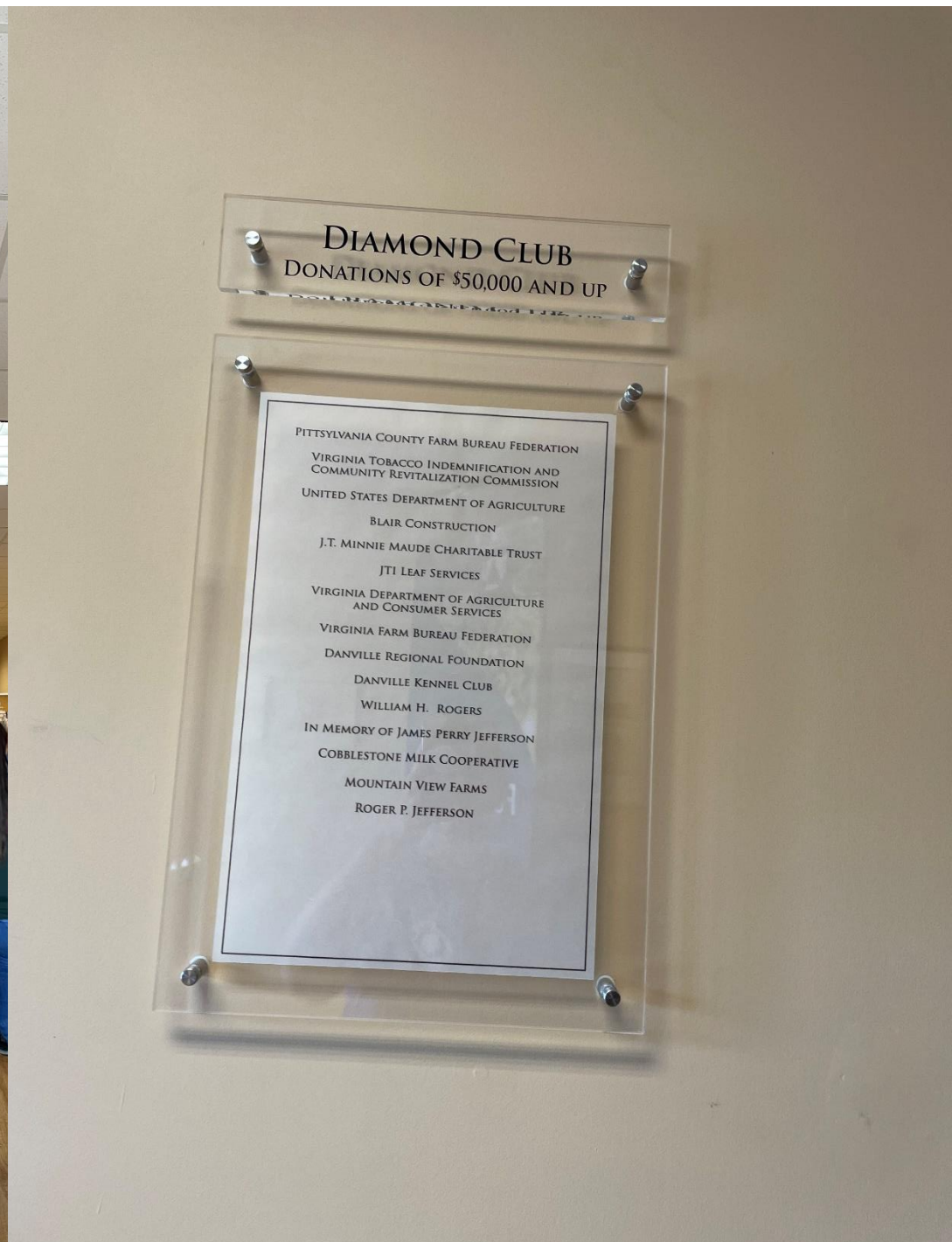
