2025 BOARD OF EQUALIZATION AND REVIEW MEETING SEPTEMBER 23, 2025

The meeting was called to order at 5:02 pm. Members of the Board of Equalization and Review in attendance were Slayton Harpe, Con Shelton, Neal Cheek, and Roy Whitley.

The first order of business was to approve the minutes from the June 10, 2025 meeting as written. A motion was made to approve the minutes by Con Shelton followed by Roy Whitley with a second. The motion was voted on and passed with no opposition.

The next order of business was an appeal from Rajesh Patel concerning a motor vehicle. Mr. Patel was not present and his case was presented by Breanna Parker representing the county. Ms. Parker provided documentation supporting an average value of \$35,728. After some discussion, a motion was made to value the vehicle at the average cost by Neal Cheek, seconded by Roy Whitley. The motion was approved with no opposition.

The next order of business was the untimely application of Ms. Juanita Cope for the elderly exclusion. Ms. Cope's son presented explaining her reason for being late. Ms. Parker presented on behalf of the county. Motion was made by Neal Cheek to approve the application followed by a second from Con Shelton. Motion was approved with no opposition.

The next order of business was the untimely application of Mr. Matthew Saylor for the disabled veteran exclusion. Mr. Saylor presented explaining his reason for being late. Ms. Parker presented on behalf of the county. Motion was made by Roy Whitley to approve the 2025 application followed by a second from Con Shelton. Motion was approved with no opposition. Motion was made by Neal Cheek to approve the 2024 application followed by a second from Roy Whitley. Motion was approved with no opposition.
